



2025 – 2026 Registration and Tuition

Registration/Enrollment – Registration fee is due at the time of Online Enrollment submission. Payment of registration fee secures student’s roster placement and is **not** applied to tuition. Registration fees are required for all students no matter what time of the year they enter the school. Registration fee is **non-refundable** and enrollment must be completed for consideration in the financial aid process.

All **Additional Fees** listed above are non-refundable, regardless of voluntary or non-voluntary withdrawal from the school before the end of the 2025 – 2026 school year.

All families are required to sign a **Diocese of Fort Worth Catholic School Tuition Contract** annually.

*All tuition is processed by automatic draft through FACTS. All financed amounts carry a non-refundable 2% administrative fee which will be charged on July 31, 2025 (example, 2% x \$8300.00 = \$166.00 administrative fee).

**Parish Certification form must be submitted annually to receive parishioner tuition rate. Tuition paid prior to submitting a certification form will not be credited/refunded.

Pay in Full:

- Due June 11, or upon enrollment if after June 11 (requires no 2% administrative fee)

Semi-Annual:

- Half due June 11 and half due December 12. (2% administrative fee on financed amount applies)

Monthly:

- Monthly installments over 10 months, from July – April. (2% administrative fee on financed amount applies.)

Families needing additional payment plan options are asked to contact business manager, Mrs. Anna Martinez, (amartinez@standrewsch.org) for assistance. **Registration and Additional fees are non-refundable. Tuition & fees are non-refundable except in verified cases of relocation out of the area which covers the Diocese of Fort Worth. Families on a payment plan are responsible for the full year of tuition payments.** Field trip fees and other incidental fees are assessed periodically. FACTS online enrollment is required for all families, regardless of the payment option chosen, with a fee of up to \$55.

Tuition assistance:

Limited funds are available through the school and through the Diocesan Tuition Assistance Fund to qualifying families who require financial assistance to attend Saint Andrew Catholic School. Families requesting tuition assistance must apply each year through FACTS. **Consideration for tuition assistance will not be reviewed until FACTS has notified us that the tuition assistance application is complete and all documentation (i.e., current year tax returns, etc.) has been uploaded.** The application can be found on the school website (www.standrewsch.org) or by following this link: <https://online.factsmgt.com/aid>.
